



## MSC 2023 "HOW TO" VIDEO SWEEPSTAKES OFFICIAL RULES

| Jun 28, 2023

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.** A purchase or payment will not improve your chances of winning. The Giveaway (the "Giveaway") entry period begins at 1:00 PM Eastern Time ("ET") on July 17, 2023 and ends at 1:00 PM ET on July 28, 2023 (the "Entry Period"), when all entries must be received. Eastern Time shall control for all purposes of this Giveaway. Sponsor's clock shall be the official timekeeper for the Giveaway. The Giveaway is governed by these Official Rules and is subject to all applicable federal, state and local laws. Void where prohibited.

**1. Eligibility.** The Giveaway is open only to legal residents of the fifty (50) United States, who are at least eighteen (18) years old or the age of majority (whichever is older) in their legal state of residence at the time of entry. Proof of residency and age may be required prior to award of any prize. Employees of MSC Industrial Direct Co., Inc. ("Sponsor"), and their respective subsidiaries, divisions, affiliates, and advertising or promotional agencies, and the immediate family and household members of such individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. "Household members" shall mean people who share the same residence at least three (3) months a year, whether related or not. In order to enter the Giveaway or receive the prize, you must fully comply with the Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Giveaway.

**2.** How to enter. To receive one (1) entry into the Giveaway, during the Entry Period, you must do the following: (1) Watch any video on the MSC "How To" playlist on YouTube; (2) comment on what you liked in the video with the hashtag #MSCHowToContest and include your Instagram or Facebook username; and (3) subscribe to the MSC YouTube channel. You must complete all 3 to receive one (1) entry into the giveaway. ALL ENTRIES MUST BE RECEIVED BY 1:00 PM ET ON July 28, 2023. Although it is free to enter, standard message and data charges may be incurred if you use your mobile device to enter the Giveaway. Limit one (1) Entry per person throughout the entire Entry Period. Entries by the same person in excess of the limits stated herein will be disqualified. Entries will be deemed to have been submitted by the authorized account holder of the Instagram or Facebook account submitted in the comment made as part of the entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Entering or attempting to enter the Giveaway multiple times through the use of multiple email addresses or accounts is prohibited and any such entries will be deemed void and disqualified.

**3. Random Drawing; Odds of Winning.** After the close of the Entry Period, one (1) potential winner will be selected in a random drawing from all eligible entries received. Odds of winning depend upon the total number of eligible entries received.

**4. Prize.** One (1) winner will receive \$500 "MSC Bucks" (approximate retail value of the prize ("ARV") is \$500). Prize will be awarded in the form of a credit to the winner's account with MSC Industrial Supply ("MSC"). Credit may not be applied towards prior purchases and is valid towards the new purchase of any MSC merchandise. Winner is responsible for any and all purchase amounts exceeding the stated ARV of the prize. If winner does not have an MSC account, it may open an account for free. All federal, state and local taxes on the prizes are the sole responsibility of the winner. Any prize or portion of a

prize not accepted, unclaimed or unused by a winner will be forfeited and will not be substituted. 7. No Tampering; Right To Cancel; Modify.
